In the event of an emergency, we will take your dog to a local veterinarian and pay for the visit and invoice you for the costs.

4	I provided proof that my dog's vaccinations for Rabies, Parvo & Distemper are current. I understand that AD&B LLC recommends dogs also be vaccinated for Bordetella/Kennel's Cough & receive a monthly preventative for canine lice.
